Where your details are provided to Mitsubishi UFJ Asset Management (UK) ("MUFG: AM (UK)") in connection with MUFG: AM (UK):

- providing its products and services from within the UK; or
- providing or offering products or services to you if you are an individual located in the UK, Middle East or Europe,

please note the following:

## Purposes of Processing and Legal basis for processing

MUFG: AM (UK) may process your personal information for the following purposes:

- Managing and administrating your holdings in any relevant fund and/or managing any account you
  may hold with MUFG: AM (UK) on an on-going basis (the "Services");
- MUFG: AM (UK) will itself (or through a third party e.g. credit reference agency) process certain information about you or your directors, officers and employees and your beneficial owners (if applicable) in order to carry out anti-money laundering (AML) checks and related actions which MUFG: AM (UK) considers appropriate to meet any legal obligations imposed on MUFG: AM (UK) relating to, or the processing in the public interest or to pursue MUFG: AM (UK)'s legitimate interests in relation to, the prevention of fraud, money laundering, terrorist financing, bribery, corruption, tax evasion and to prevent the provision of financial and other services to persons who may be subject to economic or trade sanctions, on an on-going basis, in accordance with MUFG: AM (UK)'s AML procedures;
- to report tax related information to tax authorities in order to comply with a legal obligation;
- to monitor and record calls and electronic communications for investigation and fraud prevention
  purposes, for crime detection, prevention, investigation and prosecution, and to enforce or defend
  MUFG: AM (UK) and its affiliates' rights, itself or through third parties to whom it delegates such
  responsibilities or rights in order to comply with a legal obligation imposed on MUFG: AM (UK) or to
  pursue MUFG: AM (UK)'s legitimate interests in relation to such matters or the processing in the
  public interest;
- and which processing is necessary to perform a relevant contract with you, comply with legal obligations and/or which is necessary for MUFG: AM (UK)'s legitimate interests indicated above and/or where the processing is in the public interest; and

to retain AML and other records of individuals to assist with subsequent screening of them, including
in relation to investment in funds or the provision of other services by MUFG: AM (UK), to pursue
MUFG: AM (UK)'s legitimate interests.

## Recipients of Data and International Transfer of Data

MUFG: AM (UK) may disclose your personal information as follows:

- to credit reference agencies in order to carry out money laundering and identity checks and comply with legal obligations;
- to competent authorities (including tax authorities), courts and bodies as required by law or requested or to affiliates for internal investigations and reporting; and

The disclosure of personal information to the affiliates and other third parties set out above may involve the transfer of data to other jurisdictions outside the UK or the European Economic Area (EEA). Such countries may not have the same data protection laws as your jurisdiction. MUFG: AM (UK) have put in place the Standard Contractual Clauses approved by the European Union Commission for such transfers of personal data.

#### Retention period

MUFG: AM (UK) will retain your personal information for as long as is required to perform the Services, or the service to the institution you represent, and/or for the purposes for which the data was collected, depending on the legal basis for which that data was obtained and/or whether additional legal/regulatory obligations mandate that MUFG: AM (UK) retains your personal information.

### **Data Subject Rights**

You have the following rights, in certain circumstances, in relation to your personal information:

- Right to access your personal information.
- Right to rectify your personal information.
- Right to restrict the use of your personal information.
- Right to request that your personal information is erased.
- Right to object to processing of your personal information.
- Right to data portability (in certain specific circumstances).

Where MUFG: AM (UK) requires your personal information to comply with AML or other legal requirements, failure to provide this information means MUFG: AM (UK) may not be able to provide the Services or the service to the institution you represent. You have the right to lodge a complaint with a supervisory authority.
